Dear Sir/Madam,

Reference to the previous communication dated 13.02.2024, it is once again reminded to all the establishments falling under the category of State and Central Govt. Deptts./PSUs registered with BoAT(NR) that **they pay only establishment share of stipend i.e. excluding the Central Govt. share of stipend for the month of February, 2024 payable in the month of March, 2024.** This is as per directive of Ministry of Education, Govt. of India to comply with the order so that the Central Govt. share of stipend is paid through DBT to the individual on-roll apprentices. In no case the Central Govt. share of stipend will be reimbursed henceforth. It is once again requested to take action accordingly at your end.

It is also to inform that in order to make the DBT process user friendly, full flow of DBT mechanism will be made available as a part of step-wise instruction on our website www.boatnr.org under 'Announcement' section on or before 01.03.2024. All establishments to look for the uploaded instruction and follow the process for easy implementation of DBT from 1st March, 2024 onwards.
